## **RIDE-ALONG REQUIREMENTS**

The following requirements must be met for any non-employee of the Lake Saint Louis Fire Protection District to ride in a Fire District Vehicle.

1. Must be 18 years of age or older
2. Must complete Ride-Along Request form
3. Must complete Permit, Release, and Indemnification Agreement form
4. Must obtain background check (see attached)
5. Must have both of the above forms approved by the Fire Chief
6. Must follow dress code:
  - a. Navy Blue or Grey Shirt (T-Shirts are permitted, no markings)
  - b. Navy Blue Pants
  - c. Black shoes or boots (Black tennis shoes are permitted)
7. Hours will be limited to the following:
  - a. Civilians, Monday – Friday between 7am and 7pm
  - b. Firefighters, Firefighters from other agencies may ride 24 hour shifts
8. Food and beverages are the responsibility of the person wishing to ride-along
9. All persons participating in the Ride-Along Program shall operate only as observers unless otherwise directed by a Fire District Supervisor

All persons shall conduct themselves accordingly. Inappropriate behavior will not be tolerated and could cause immediate dismissal from the Ride-Along Program

## **RIDE-ALONG PERMIT, RELEASE AND INDEMNIFICATION AGREEMENT**

I, \_\_\_\_\_ in consideration of being granted permission to ride in a Lake Saint Louis Fire Protection District Vehicle and accompanying a firefighter(s) for the sole purpose of observing and becoming familiar with the operation of a Lake Saint Louis Fire Protection District firefighter, do hereby indemnify, save harmless, release and discharge the Lake Saint Louis Fire Protection District, and any of its officers, employees or volunteers from any liability to me, my employer, my assigns, my heirs, my executors and personal representatives now and forever, for any claim by reason or on account of any injury to myself or my property, whether by reason of intention or neglect, including negligence on the part of the Lake Saint Louis Fire Protection District itself, during such time that I may be in a vehicle of the Lake Saint Louis Fire Protection District or in the company of an officer, employee or volunteer of the Lake Saint Louis Fire Protection District discharging his/her duties.

I assume all risks of death, injury, loss or damages to my person or property, whether due to intention or neglect, including negligence on the part of the Lake Saint Louis Fire Protection District itself, and neither myself nor any of my representatives shall have any claim against the Lake Saint Louis Fire Protection District, its officers, employees or volunteers by reason of my death, injury, loss or damage.

I also agree to indemnify and hold harmless the Lake Saint Louis Fire Protection District for any loss, damage, injury, attorney's fees, expenses, or claims arising and resulting from my actions while riding in a Lake Saint Louis Fire Protection District Vehicle and associated actions.

## MISSOURI STATE POLICE CRIMINAL HISTORY RECORD REQUIRED

### Missouri State Background Check

A state criminal history search collects criminal records from a database in a specific state. The idea is for counties and jurisdictions around the state to report new arrests, warrants, charges, and convictions to the central state repository. Employers use these state-level criminal checks to widen the scope of their background checks.

This Missouri background check includes a search of the statewide criminal repository maintained by the Criminal Justice Information Services (CJIS) Division of the Missouri State Highway Patrol. The check will yield criminal history details from any Missouri counties that report to the CJIS database. Counties that may be represented in this Missouri state background check include St. Louis County, Jackson County, and St. Charles County. At backgroundchecks.com, we process state criminal checks in 45 states, including Missouri.
